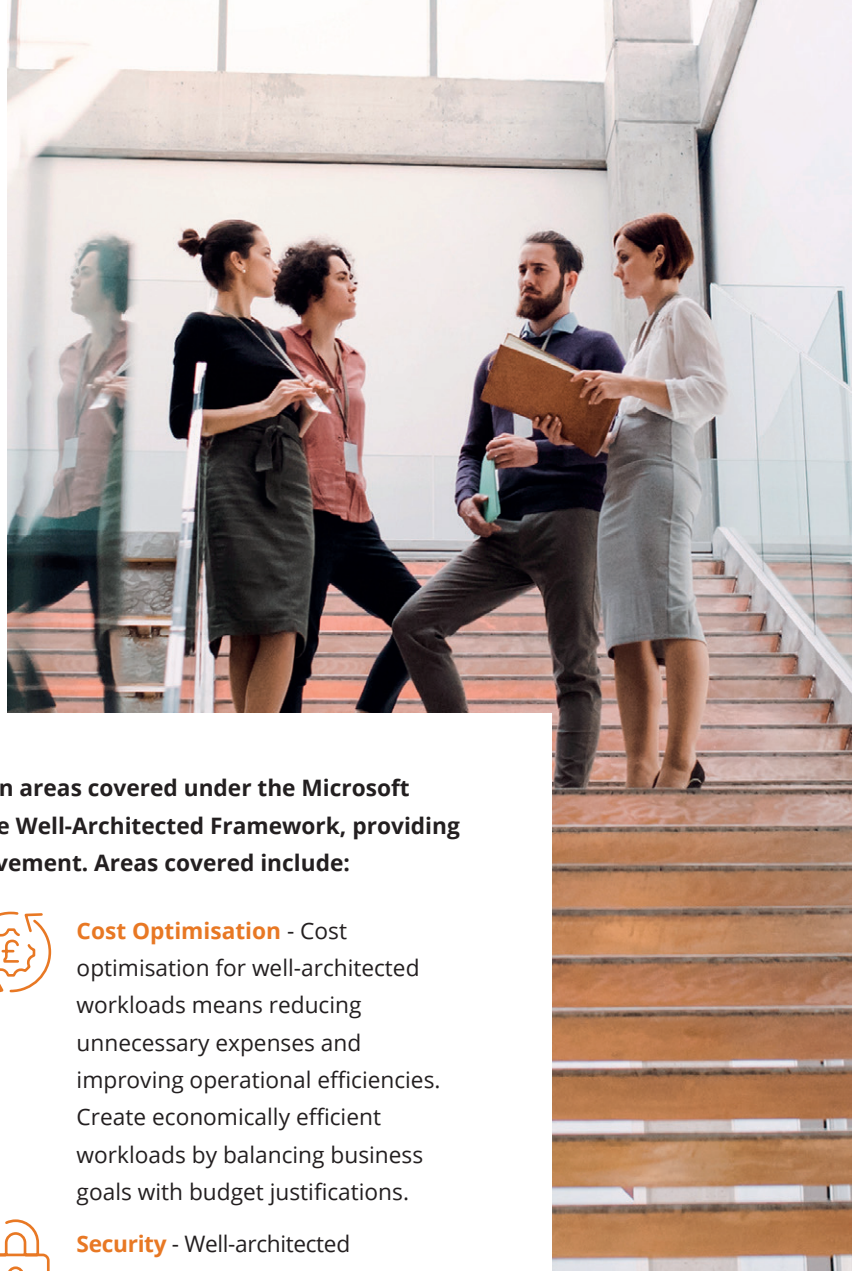




Azure Optimisation Review
