ALB Connect is our new, configurable API framework which allows ALB to automatically interact and share data with 3rd party providers.

This innovative tool takes advantage of the Rest API (application program interface) functionality that is widely used by many modern applications. This API acts as a channel between 2 pieces of software and allows them to communicate efficiently with one another.

Making the complex simple

The core function of ALB Connect is to act as an information delivery mechanism. This channel compiles an information request, along with any required data, directly from ALB. Everything is then transferred to an authorised 3rd party who will process the request. ALB Connect completes the procedure and delivers the required results directly back into ALB.

Faster matter completion

The conveyancing process is a good example of how ALB Connect can help your firm save time. Property transactions require local searches to be delivered and reviewed before matter completion. This requires the services of a 3rd party search provider.

In order to get the correct reports, conveyancers need to inform the search provider about the type of searches they require, along with the details of the property they need them for.

ALB will already have all of the required information in its database. With ALB Connect, it's fast and easy to instantly pass that information, in the required format, to the search provider.

Easy integration

The functionality within ALB Connect allows user firms to create new integrations (communication channels) quickly and easily. Additional channels can be added at any time they are needed.

All data fields required by the 3rd party provider are clearly displayed and the operator simply selects the relevant ALB field for each one using the existing data field picker.

Once this information is saved, the integration can be called from a workflow, and responses saved to contact or matter level ALB fields.

Workflows can also be listed in the actions menu, allowing non-workflow users to take full advantage of the benefits of ALB Connect.
