Create and manage Ministry of Justice (M0J) claims directly from P4W

You can create and manage claims directly from P4W, removing the need to log into the MoJ portal separately. Your fee earners can easily upload claims, settlements and court packs directly from within P4W.

All forms can be produced as required at the click of a button and saved in the case agenda. The downloading of data is handled by web services in the background. P4W TaskCentre notifies the appropriate fee earner when an event has occurred on the case, normally via email, and claim statuses are viewable at a glance. Once submission of the data to the MoJ portal has occurred, the data screen becomes 'read only' and no further copies can be created. Copies can be downloaded as required.

The P4W Claims Management module contains all of the tables and fields required for claims, whether claimant or defendant, and firms can integrate these into their existing templates if they wish. A separate case agenda is automatically created to display an event history of interaction with the MoJ Portal on each case. GT Stewart used P4W and FormShare automation to radically restructure police station client inception in order to make criminal law financially viable.

GT Stewart's challenge was to use our software to automate as much of this work as possible in order to reduce costs and improve data quality and security.

Now, a digital form held on a laptop is completed at the police station. This carefully structured, 9-page form is efficient and accurate, plus a time record is created.

Once submitted digitally to the firm, the information goes directly into P4W where the software instantly:

> Checks for conflicts and executes a compliance check

> Opens a new client record, if required, and opens a new client file

> Time records the complex legal aid time and fixed fees.
 > Initiates the automated billing process
