#### A single point of data entry

Contacts added to Outlook can be simultaneously added to Link Legal. This means there is no duplication of contact data, and because the data is synchronised between both systems, the contact record in Outlook is always identical with that in Link Legal.

#### **Contact preferences**

Remembering contact preferences is a key factor in showing contacts that they are important to your firm. Continually asking them the same questions gives the impression they're just a number. Link Legal captures those vital contact preferences through firm specific segmentation and tracking fields.

#### **Profile contacts**

All contacts and companies can be comprehensively profiled. This profiling and activity data can be used in combination to search for, and accurately target, tightly focused groups of contacts.

#### **Track marketing activity**

Marketing activity can be tracked at the individual contact level. Leads from your firm's website, emails received, and events attended, can also be tracked. #### **Email marketing**

The e-marketing component within Link Legal makes it straightforward and quick to generate, send and manage bulk emails. It also ensures campaigns and communications are timely and responses automatically recorded.

This is based on the core concept of 'closed loop communications' – which means that Link Legal records the results of your firm's e-marketing interactions directly within the CRM.
