Digitised fee collection

Generated fee notes, documents, letters, bills, or receipts can be easily added to Legal Live. This allows you to provide related parties with the full financial details for all of their cases.

You will also have the option to provide client finance teams with access to a global view of the financial status of their cases. This proactive transparency will provide them with instant visibility of their wider debt status, helping your chambers to reduce the quantity of fee queries or late payments and shortening the bill to cash cycle.
