## Meeting complex invoicing requirements

### The regulations

Each country has different regulations, which businesses must seamlessly implement within their own invoice or purchase order services:

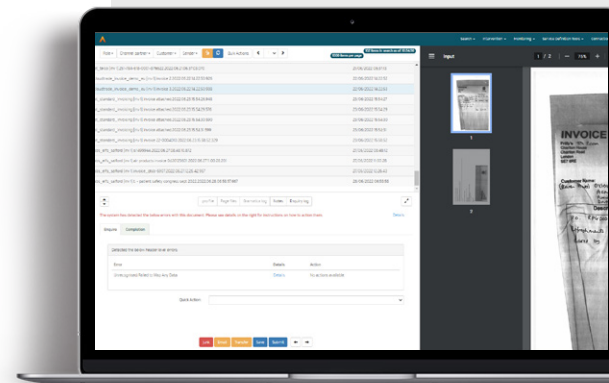
- In Brazil, transactions are registered within a government portal. This provides a barcode or access key which must be included, decoded and double-checked against the contents of an invoice.
- Argentine invoices carry revenue codes which need to be captured and integrated with their invoice number. They must also be checked to ensure they conform to a particular format.
- Mexico, Chile and Peru require supplemental XML files to be submitted and cross-checked against their invoices.

### The rewards

These data capture requirements are complex and require businesses to work with Government-supplied data files to ensure compliance. For large- and medium-sized businesses based in Latin America and the United States, meeting these requirements for processing invoices is a significant barrier – but one that's worth overcoming.

The Latin American market is huge. Even after the debilitating effects of the coronavirus pandemic, Brazil has the ninth-largest economy in the world, and Mexico the fifteenth.
