LAND REGISTRY – FOR IMMEDIATE USE

The Land Registry has updated the side notes on the following form. The form is now available in Laserform for immediate use however the current version will remain acceptable indefinitely.

INSOLVENCY (SCOTLAND) – FOR IMMEDIATE USE

The Insolvency (Scotland) (Company Voluntary Arrangement and Administration) Rules 2018 and The Insolvency (Scotland) (Receivership and Winding Up) Rules 2018 came into force on 06 April 2019 and replace The Insolvency (Scotland) Rules 1986 and their numerous subsequent amendments. Companies House now prescribe a number of insolvency forms based on the new rules.

The following two new forms received last minute amendments from Companies House but are now available in Laserform for immediate use.

IMMIGRATION – FOR IMMEDIATE USE

The Home Office has updated the following form for immediate use. In line with Rule 34Y of the Immigration Rules, where an application is made no more than 21 days after the date on which a form is specified (within the meaning of paragraph 34) and on a form that was specified immediately prior to the date of the new specification, the application is deemed to have been made on the specified form (and is therefore not to be treated as invalid by reason only of being made on the "wrong" form).
