IMMIGRATION - FOR IMMEDIATE USE

The Home Office has updated the following forms for immediate use. In line with Rule 34Y of the Immigration Rules, where an application is made no more than 21 days after the date on which a form is specified (within the meaning of paragraph 34) and on a form that was specified immediately prior to the date of the new specification, the application is deemed to have been made on the specified form (and is therefore not to be treated as invalid by reason only of being made on the "wrong" form).

VAF2 Apply for entry clearance for more than 6 months: work, study, dependants 700008 10/19 and right of abode
