Companies House has confirmed that they will now reject share capital forms when the 'unpaid amount' fields are left blank, instead these fields should contain '0' or 'nil' if there is no amount unpaid. The following forms have been amended to include a default '0' unless another figure is entered or calculates into those fields.
