### Company for Immediate Use

[The Administration \(Restrictions on Disposal etc. to Connected Persons\) Regulations 2021](#) came into force on the 30th April 2021. These regulations introduce a requirement - in certain specified circumstances - to deliver a qualifying report and statement along with the AM03 form. These forms have been amended to include a new Section 7, and are now available for immediate use.

[The Assured Tenancies and Agricultural Occupancies \(Forms\) \(Moratorium Debt\) \(Consequential Amendment\) \(England\) Regulations 2021](#) came into force on the 4th May 2021. LTA3(E) has been updated to reflect the breathing space (debt respite scheme) regulations, which affect the ability to serve notice and make a possession claim under Section 8 of the Housing Act 1988 in certain circumstances. The latest version is now available for immediate use.
