

## Form Updates for Laserform & Cloud Forms

Update No: **872** Date: **06 April 2022**

This bulletin contains information about Company, HMRC, Immigration, Office of the Public Guardian, Legal Aid, Licensing and Matrimonial (*information only*) forms.

### Company for Immediate Use

Companies House have updated AA01 and LLAA01 to include additional notes regarding paper notifications. There is no change to the form content and the current version will remain acceptable for filing.

SH01 has been redesigned to take into account stamp duty payment exemptions for Qualifying Asset Holding Companies, which came into force on 01 April 2022. It also references a change to HMRC processes with regards to stamping when duty is payable. Companies House will continue to accept the current version of the form, but recommend using the updated version to avoid unnecessary registration delays.
