LAND REGISTRY – FOR IMMEDIATE USE

HM Land Registry has been working with the Commercial Arrangements Section to create a new promulgated form ADD. This form is to be used by lenders when they submit a deed for variation of a charge, for priority of a charge or for postponement of a charge. The new form is available in Laserform for immediate use. LRACD has also received minor amendments however the current version will remain acceptable indefinitely.
