## Legal Aid for Immediate Use

The Legal Aid Agency has updated the following Escape Fee Case Claim forms into Excel format with a validation requirement that each field must be completed in turn, to ensure that no information is missed out.

- LAECCLAIM1(IMM)
- LAECCLAIM1(MH)
- LAECCLAIM1CIVIL
- LAECCLAIM1CLA

This is not a format currently supported by Laserform and we will therefore be unable to reproduce these updated forms. The current versions will be acceptable until 14<sup>th</sup> October 2022 and then they will be withdrawn to avoid accidental use.
