From 30th November 2022, AP1 applications to change the register must be submitted digitally, in line with HM Land Registry's <u>Digital by Default</u> strategy. We will retain a paper version of the LRAP1 in Laserform Desktop and Cloud Forms Library however this is for information gather purposes ONLY and must not be submitted, either as PDF/scanned upload or by post.
