Following customer feedback, the LPE1 form has had minor amendments made to some field lengths. As there is no content changes on this form, the date stamp remains the same and the previous version will continue to be acceptable.

The remaining forms have been updated further to new provisions of the Building Safety Act which have come into force resulting in some mortgage lenders imposing new requirements for flats that may be affected by defects covered by the Building Safety Act.
