Court for immediate use

HMCTS have updated the following forms; details of the changes are as follows:

- **EX50** The EX50 is no longer available in paper form from HMCTS therefore it has been withdrawn from the library to avoid accidental use; the latest fees information can be found here.
- **N1** Following customer feedback, the N1 has received minor amendments to fields on page 1, as there are no content changes on this form, the date stamp remains the same and the previous version will continue to be acceptable.
- **N180** Updated with questions on the use of Welsh by witnesses in court, for giving evidence and for producing documents in court being added; these questions are under the 'Other information' section.
- **N181** Intermediate track option has now been added to the 'Allocation to track' section. Guidance on the use of the Welsh language when filing witness evidence has also been added to the 'Witnesses' section.
- **N244** Further to customer feedback, the N244 has received a minor amendment to accommodate additional characters in the claim reference number field. As there are no content changes on this form, the date stamp remains the same and the previous version will continue to be acceptable.
