Following the annual review of the content of the Buying and Selling Property Information (BASPI), undertaken by the Home Buying and Selling Group, a revised version has been released which is now available for immediate use.

In addition, the **TA6 Property Information Form** and **TA7 Leasehold Information Form** have received minor formatting changes to increase user functionality following feedback from the Law Society. Both forms are available for immediate use and must be used from 25th June 2024.
