MULTILEX LICENCE TERMS

Multilex software is a third party software product licensed by First Databank Europe Limited (FDBE).

A Customer's use of Multilex is governed by the terms of the Sub-Licence Agreement set out below.

IMPORTANT --- PLEASE READ CAREFULLY

SUB-LICENCE AGREEMENT

Definitions:

"AHC" Advanced Health and Care Limited, formerly Adastra Software

Limited (registration number 2939302).

"AHC Product" the AHC software product licensed to the Licensee pursuant to the

terms of the Agreement.

"Agreement" the agreement between AHC and the Licensee under which AHC

supplies the AHC Product and Product.

"End User" any of the number of Representatives of the Licensee permitted to

use the Product as set out in the Agreement.

"FDBE" First Data Bank Europe Limited (registration number 01880682).

"FDBE Agreement" the agreement between AHC and FDBE under which AHC is granted

the right to sub-licence the Product.

"Licensee" the customer of AHC who party to the Agreement.

"Product" the object code version of the FDBE Multilex DDF database and

associated software ("toolkits") incorporated into the AHC Product supplied to the Licensee by AHC pursuant to the Agreement, together with any updates, modifications, enhancements, fixes and new versions (if any) as may, from time to time, be provided to the Licensee by FDBE whether directly or via AHC. The term "Product" also includes any associated user documentation and other written materials which may be provided to you by FDBE for your use in

connection with the Product (the "Documentation")

"Representatives" any person authorised by the Licensee to use the Product.



Other terms used in this licence agreement but defined in the Agreement shall have the same meaning as defined in the Agreement unless the context otherwise permits.

Please read the terms of this licence agreement carefully. AHC supplies the Product to the Licensee pursuant to the terms of the Agreement and in accordance with terms and conditions of this licence agreement. For the avoidance of doubt the Product represents "Third Party Software" as defined in the Agreement. If there is any conflict between the terms of this licence agreement and the Agreement, the terms of this licence agreement shall prevail. The Licensee's right to use the Product is subject to the terms set out in this licence agreement. By installing, copying or otherwise using the Product, the Licensee accepts and agrees to be bound by the terms of this licence agreement, including the disclaimers, limitations of liability and termination provisions below, and the Licensee represents and warrants that has the power and authority to enter into and perform this licence agreement. Such acceptance is both (a) on the Licensee's own behalf, and (b) on behalf of the Licensee's Representatives In this licence agreement, the term "Licensee" includes any such Representative.

Licence

AHC grants the Licensee a limited, non-exclusive, non-transferable licence to install and use the Product on such number of terminals and for use by such number of End Users as is specified in the Agreement. The Licensee may use the Product only for its own internal business purposes for the benefit of any medical practice for which the Licensee is responsible and only in accordance with the Documentation (if any).

In the event of a breach of any obligations or restrictions contained in this licence agreement, AHC reserves the right to suspend the Licensee's (and all Representatives) access to the Product until such breach has been remedied.

Acceptance of Licence

The terms of this licence agreement are deemed accepted by the installation and use of the Product by the Licensee or any Representative.

Disclaimer

IMPORTANT NOTICE:

All information is provided from the Multilex database on the basis that the healthcare professionals responsible for patient care will retain **FULL** and **SOLE** responsibility for deciding what treatment to prescribe or dispense for all patients and, in particular whether the use of any drug or other product is safe, appropriate or effective for any particular patient or in any particular circumstances.

This is because (and all healthcare professionals should bear in mind):

1. The Multilex database is intended to supplement, not substitute for, the expertise and judgment of physicians, pharmacists or other healthcare professionals.

- 3. While the Multilex database uses reputable sources of information, such as published data of pharmaceutical manufacturers, it does not validate or verify the information received from third parties.
- 4. The information stored on the Multilex database is not exhaustive. It therefore cannot be relied upon as complete.
- 5. Although the information stored on the Multilex database is updated on a regular basis, healthcare professionals should ensure that they are satisfied that the information they have is current.

Ownership and Intellectual Property

The Product is licensed to the Licensee, not sold. All rights in and to the Product are owned by FDBE and/or its third party suppliers, including all rights provided under copyright law, trademark law, patent law, database law, trade secret law, and all other forms of proprietary and intellectual property protection. Except for the limited licence granted above, the Licensee shall not have any rights in the Product. The Licensee agrees to reproduce the copyright and other notices relating to the rights of FDBE and its suppliers on every copy or partial copy of the Product the Licensee makes. The Licensee may not remove, obscure or modify any such notices.

Copies

The Licensee is permitted to make as many copies of the Product as is reasonably necessary for operational security, disaster recovery or back-up purposes in so far as the making of those copies is necessary for the use of the Product permitted by this licence agreement. Such copies shall in all respects be subject to the terms of this licence agreement and shall be deemed to form part of the Product.

Restrictions

The Licensee acknowledges and agrees that the Product, including its source code, structure, sequence and organization, contains confidential and proprietary information and valuable trade secrets of FDBE and/or its suppliers. The Licensee may not allow any third party use or access the Product, except third-party contractors who need access to the Product to perform services for you and who have agreed to be bound by the terms and conditions of this licence agreement.

The Licensee may not, and the Licensee may not authorise or permit third parties to (a) use, copy, modify, or prepare derivative works of the Product or any part thereof, except as expressly authorized in this licence agreement; (b) distribute, lease, sublicense, lend, give, transfer, assign or otherwise make all or any portion of the Product available to any third party, except as expressly

authorised in this licence agreement; (c) save as expressly permitted by applicable law, reverse engineer, decompile or disassemble the Product or cause or allow discovery of the source code of the Product or attempt to do so, and, to the extent permissible by law, the Licensee waives any rights that it may have to do any of the foregoing; (d) use the Product for service bureau, ASP service, subscription service, time-sharing arrangement, or for any other type of commercial venture that generates revenue as a direct result of the Product without FDBE's prior written consent.

Maintenance

Any maintenance or support to which the Licensee is entitled will be provided by AHC under the terms of the Agreement FDBE has no obligation to provide any maintenance or support for the Product to the Licensee or directly to End Users.

Representatives

The Licensee agrees to:

- (a) procure that all its Representatives comply with the provisions of this licence agreement and the Agreement and any obligations or restrictions imposed on the Licensee under the terms of this licence agreement and the Agreement;
- (b) be responsible and liable for all acts, omissions, misconduct, breach, fault, default or negligence of, or by, the Representatives arising in respect of or in connection with, such obligations or restrictions or use of the Product;
- (c) indemnify AHC for any loss, liability or damage that AHC may suffer or incur as a result of such acts, omissions, misconduct, breach, fault, default or negligence.

Accordingly, neither FDBE nor AHC shall be responsible for any use the Licensee or its Representatives make of the Product. End Users of the Product who are registered medical practitioners, or others legally authorised to prescribe or dispense drugs or other pharmaceutical products, shall be fully responsible and liable for any use which they make of the Product as incorporated in their



computer systems in prescribing or dispensing substances to be taken by patients or otherwise used as part of their therapeutic treatment and care.

For the avoidance of doubt, nothing in this licence agreement shall be construed so as to limit or exclude FDBE's or AHC's liability for personal injury or death caused by its negligence, or for fraudulent misrepresentation.

Indemnification

The Licensee agrees to defend, indemnify and hold AHC and its affiliates and any of their respective directors, officers, employees, or agents harmless from and against any and all claims, losses, liabilities, demands, damages, judgments costs and expenses, including attorneys'fees, arising from or relating to any breach of this licence agreement or the Licensee's use of the Product.

Termination

The licence granted under this licence agreement shall immediately and automatically terminate on:

- (a) termination of the Agreement in accordance with its terms;
- (b) termination of the FDBE Agreement;
- (c) upon failure by the Licensee to comply with its terms. AHC reserves the right in its sole discretion to terminate this licence granted under this licence agreement, upon e-mail notice to you or upon notice posted on AHC's web site. Upon the termination of the licence granted under this licence agreement, the Licensee must cease and procure that all Representatives cease all use of the Product and destroy or return to AHC all copies of the Product in the Licensee's possession or under its control. Unless mutually agreed in writing by the parties, all other terms of this licence agreement will remain in effect following termination of the licence.

Rights of Third Parties

Save as expressly provided herein in respect of FDBE, no term of this agreement shall be enforceable under the Contracts (Rights of Third Parties) Act 1999 by a third party.

Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the law of England. The parties irrevocably agree to submit to the exclusive jurisdiction of the courts of England over any claim or matter arising under or in connection with this Agreement.

Assignment

The Licensee may not transfer or assign the Product or any of its rights or obligations under this Agreement without AHC's prior written consent.

Severability

In the event any term or provision of this Agreement or any application thereof shall be deemed to be illegal, void or unenforceable, then the same shall not affect the remaining portions of this Agreement or any other application of the same that are not determined to be illegal, void or unenforceable, which remaining provisions and any other such application shall survive and constitute the agreement of the parties.

Miscellaneous

No amendment to this licence agreement shall be binding unless made in writing and signed by a duly authorised representative of the party against whom enforcement is sought. Whenever the consent of a party is required, such consent may be withheld in that party's sole and absolute discretion. The failure of either party at any time to require performance of any provision of this licence agreement or to exercise any right provided for herein shall not be deemed a waiver of such provision or such right. All waivers must be in writing. Unless the written waiver contains an express statement to the contrary, no waiver by either party of any breach of any provision of this licence agreement or of any right provided for herein shall be construed as a waiver of any continuing or succeeding breach of such provision, a waiver of the provision itself, or a waiver of any right under this Agreement. All remedies provided for in this licence agreement shall be cumulative and in addition to and not in lieu of any other remedies available to either party at law, in equity or otherwise. This licence agreement contains the entire understanding and agreement between the parties with respect to the subject matter hereof and supersedes and merges herein all previous communications, negotiations and agreements, whether oral or written, between the parties with respect to such subject matter.
